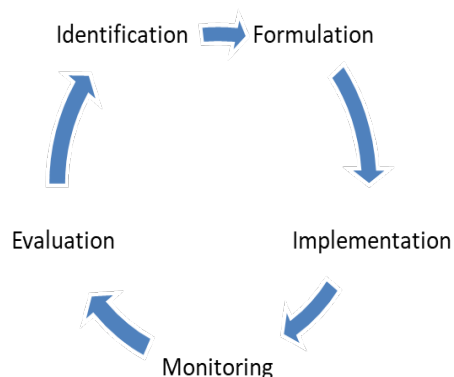

1.0 Background:

GSF was incorporated and registered with the Uganda Registration Services Bureau on 28 January 2020. That year, operations were crippled by the COVID-19 pandemic and its attendant lock-down, which did not allow for implementation of planned activities.

In 2022, GSF resumed work, with major focus on getting registered with the National NGO Bureau as an Indigenous Non-Governmental Organisation (NGO). The project is going through the Project Cycle Management and is steadily moving from the stage of Formulation to the point of implementation as below;

3.0 Progress made against planned activities

3.1 GSF fully registered with the NGO Bureau

The required documents were submitted to the NGO Bureau, pending approval by 05 January 2023. (The reception slip from the NGO Bureau is annexed to this report as Annex 1.)

Payment of UGX 400,000 for the 5-year permit was done at the Ministry of Internal Affairs. UGX 100,000 was towards registration with the NGO Bureau, while UGX 60,000 x 5 was paid for each of the 5 years covered by the requested permit (UGX 300,000), making a total of UGX 400,000. 3.3 Support at least 10 children with Education Aid

8 vulnerable children have been identified and supported with school dues at Kigo Prisons Primary School throughout the year 2022.

The school was selected because of its dire need for support. It is a government aided school, but serves the fishing community, which comprises of mainly under-privileged children.

Of the 8 children, 3 are boys and 5 are girls and they are mainly from P1 – P4. Majority of the beneficiaries are from single-mother headed households.

3.4 Grow the board from 3 to 8 members

- Initially, the Board had only 3 members, i.e, Ms. Ruth Kato (Founder & Chairperson, Ms. Elsa Mugyenzi (Treasurer) and Ms. Rebecca Kizito (Board Secretary). This year, the Board of Directors has grown from 3 members to 5 members with the introduction of Ms. Christine Waligo and Mr. Martin Roy Lukwago on 19 October, 2022.
- Plans to grow the board further did not materialize, but we will re-visit the process with a view to balance the gender equation.
- The Board of Directors held 4 quarterly meetings, at which issues to do with the functioning of Good Shed Foundation were discussed. Minutes of all meetings are filed. In addition to the usual quarterly meetings, Extra-ordinary meetings were also held to agree on and eventually file board resolutions with the Uganda Registration Services Bureau;

Board resolution to register GSF as an NGO.

Board resolution to admit two new members to the Board

Board resolution to adjust the Memorandum & Articles of Association to mention how assets would be treated in the event that GSF was dissolved. It was agreed that assets would be used to firstly pay off creditors (if fany) and whatever remains would be donated to an NGO carrying our similar work like Good Shed Foundation.

Effort will be made to increase the number of Board members further and to balance the gender equation with moremen since the current Board comprises of more women than men. The other potential board members are;

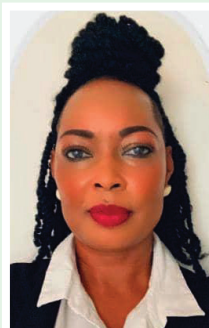

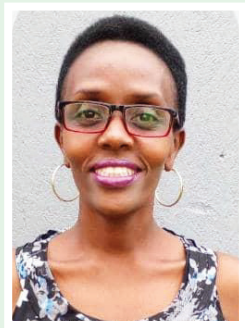

3.5 Join the local forum for CBOs and NGOs

Following recommendation by the Katabi Town Council, GSF was included on the local mailing list of the NGO Network. In order to be a full member of the Network of CBOs and NGOs in Katabi Town Council, Wakiso District, GSF has to pay for Membership and Annual subscription. Since we got to know about this forum in the last quarter of the year, it was decided that we wait for January 2023 to pay the annual subscription (UGX 120,000 membership + UGX 70,000 for annual subscription).

GSF was welcomed onto the Network and included on the Whatsapp group where information about NGOs is shared.

It is at this forum that GSF contributed UGX 200,000 towards preparations for commemoration of the International World Aids Day on 01.12.2022.

GSF also attended all meetings of the forum in the last quarter of 2022.

3.6 Participate in the Day of the African Child and World Aids Day celebrations.

- GSF contributed UGX 200,000 to the Town Council organization for celebrations to mark the International World Aids Day on 01 December 2022.
- The organization was not yet a member of the Network of CBOs by June

2022 and therefore did not participate in the celebrations for the Day of the African Child. However, GSF will participate next year.

3.7 Open a bank account for the organization

3.8 Raise at least 30M through Fundraising

- UGX 9,600,000 has been raised through fundraising from Well-wishers / Partners, Board members and the general public.
- The target of UGX 30M was not met because the fundraising channels e.g MTN Merchant code, are still pending completion. There is also need to intensify on reaching out to different people and organizations with a view to growing our fundraising base.

3.9 Support at least 5 vulnerable elderly people with basic needs

Five (5) elderly vulnerable people were visited on 03 September. GSF supported them with basic needs like sugar, soap, salt, rice, posho etc and encouraged them in the love of God.

3.10 Open a postal address for GSF

3.11 Register for a Tax Identification Number with URA

The GSF **Tax Identification Number** was secured with Uganda Revenue Authority

and the number is **1027230169**. The organization filed Zero Tax Returns in November 2022 for the year. A letter was written to URA on 15.12.2022, clarifying that GSF is not liable to pay PAYE as yet, since we have not recruited staff yet.

3.12 Identify and assess vulnerable youth for Vocational Skills Training

No progress has been made on this activity this year. GSF will start assessing youth next year and sign MoUs with Vocational Skills institutions to support them.

Challenges faced in the reporting period

The lengthy process of registration with the NGO Bureau has been a challenge. The organization was required to present recommendation letters from various entities, each of which took lots of time and resources.

The organization found that there are too many vulnerable children needing support, yet the finances to support them are limited.

Considering that the organisation does not have employees yet, the Board

members had to step in and do a lot of voluntary work, in order to get the organization up and running.

Insufficient funds has been another challenge. Before formal registration with the NGO Bureau, it has not been easy to invite donors, so the Board members have had to foot most of the bills related to ensuring that the organization is registered and also paying tuition for the existent beneficiaries.

6.0

Visibility & Partnerships

On 28th December 2022, JESA Dairy Farm, the largest producer of farm-milk products in Uganda, partnered with Good Shed Foundation to put a “Yoghurt smile” on the faces of GSF beneficiaries. Both the young and old were elated to receive lots of yoghurt and this is the start of a long term mutually beneficial partnership between GSF and JESA Farm.

JESA Farm Dairy is a family owned dairy founded in 1989 by the late Mr. James Mulwana. From its small beginnings as a local dairy producing only raw milk, JESA has become a home grown, commercial success story and a flagship East African consumer brand. Today, the JESA brand has a wide range of fresh, dairy products: namely fresh Pasteurised milk, UHT Milk, Yoghurt, Butter, Fresh Cream and Cream Cheese.

8.0 Resources required for 2023

For successful implementation of the 2023 plan, the following resources will be required;

- Finances (Approx. UGX 20M for school fees,)
- Computers for use by the volunteers
- Office running expenses (Approx. UGX 10M)
- Human Resources, mainly volunteers to support daily operations.
- Renewal of the GSF website and active use of the social media handles. This will also require purchase of an official Android phone solely for social media.
- UGX 40-50M to purchase land for construction of a permanent office in the next 5 years.
- UGX 5M for visibility materials i.e branded tent, banners, etc
- Invest approx. 10M towards launch of GSF as a fundraising event to raise UGX 20M
- UGX 5M to produce a documentary of GSF work/impact in the community.
